Active Travel (Wales) Act 2013: Annual Report on Active Travel

In accordance with the duties under sections 7 (3) and 10 (2) of the Active Travel (Wales) Act 2013 outlined below is Flintshire County Council's annual report.

Actions taken to promote active travel journeys 2016/17

1.0 Road Safety

1.1 Kerbcraft Training has been delivered to approximately 281 year one pupils across primary schools in Flintshire.

1.2 National Standards Cycle Training was delivered to approximately 787 year 6 pupils across Flintshire schools.

2.0 Active Travel Consultation/Engagement

2.1 Flintshire County Council in conjunction with Sustrans held Active Travel Journey workshops with Ysgol Glan Aber in Bagillt.

2.2 Officers attended the Flintshire Disability Forum at Mold in March 2017 to consult on the draft proposals for its Integrated network Map and promote the benefits of Active Travel journeys through discussions.

3.0 Websites/ Social Media /Publication

3.1 Publicised the Existing Route Map on Flintshire County Council's Active Travel Web Page and its Annual Report 2015/16.

3.2 Updated Flintshire's Active Travel web page with additional links and documents relating to Active Travel.

4.0 Cycling Schemes

4.1 Flintshire County Council continued to operate its Cycle to Work Scheme and Borrow a Bike scheme.

The actions taken to secure new active travel routes and related facilities and improvements 2016/17

5.0 Infrastructure secured through the Planning Process

- 5.1 New shared use link to new medical Centre in Flint.
- 5.2 Off site footway provision and footpath improvements in Higher Kinnerton linking new residential development with Village Centre, school and bus stop.
- 5.3 Off site footway provision serving new residential development in Buckley.
- 5.4 Off-site footpath linking residential development to retail park in Broughton.

6.0 Other Schemes

- 6.1 Secured £289,000 through the 2017/18 Local Transport Fund with a £78,000 match funding contribution from FCC for the delivery of Community Transport Hubs and related Active Travel Improvements.
- 6.2 Secured £295,000 through the 2017/18 Safe Routes in Communities Fund to deliver safety schemes at Ysgol Bryn Coch, Mold and Ysgol Golftyn, York Road, Connahs Quay.

Costs incurred for new active travel routes and facilities and improvements of existing active travel routes and related facilities carried out in the preceding full financial year

7.0 Schemes completed 2016/17

- 7.1 Upgrade of zebra crossing to a puffin crossing at Trelawnyd Primary School, London Road, Trelawnyd. The scheme also included upgrading of street lighting. Cost £62,500
- 7.2 Active Travel footways throughout Mold Town Centre received slurry sealing. Cost £30K
- 7.3 Visi rails repainted and canopy refurbished in Mold High Street. Cost £25,000
- 7.4 Provision of directional traffic island for a one way system on a section of Penymynydd Rd, Penymynydd to improve safety for pedestrians. Cost £10,000
- 7.5 Street cleansing of the Deeside Corridor including bus shelters. Cost £23,000
- 7.6 Provision of new and improved dropped crossings and tactiles and replacement of damaged visi rails on Active Travel routes throughout the Deeside Corridor. Cost £29,000
- 7.7 Provision of cycle link with improved crossing points for walkers and cyclists at Belvedere Close in Queensferry. Cost £25,000
- 7.8 Provision of cycle refuge at Queensferry Roundabout. Cost £5,000
- 7.9 Cleansing Programme along Shotton Lane, Shotton. Cost £1,800
- 7.10 Delivery of Transport hubs, dropped crossings and footway resurfacing throughout Flintshire. Cost £184,000
- 7.11 Slurry Sealing of Active Travel footway on Whitford Street., Holywell. Cost £900.
- 7.12 Upgrade of Street Lighting columns and lanterns on Deeside Corridor. Cost £100,000.
- 7.13 Upgrade of Street Lighting columns and lanterns on Station Road, Queensferry. Cost £65,000.

7.14 Replacement of old lanterns with energy efficient lanterns across Flintshire.
£150,000

7.15 The total cost incurred for the last financial year £711,200.
