

## NOTICE OF PROPOSAL

### THE FLINTSHIRE COUNTY COUNCIL (VARIOUS ROADS WITHIN FLINTSHIRE) (30 mph Speed Limit) (Amendment 1) Order 202-

The Flintshire County Council hereby gives notice that it proposes to make an Order under Sections 82 (2) (a), 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers the effect of which will be to amend The Flintshire County Council (VARIOUS ROADS WITHIN FLINTSHIRE) (30 mph Speed Limit) Order 2023, as though in the fifth Schedule to that Order, the words :-

**A5026 HOLWAY ROAD, HOLYWELL:** from a point 680 metres North West of its junction with Saith Aelwyd Park, to a point 52 metres north west of its junction with Carmel Road.

are deleted and replaced with:

**A5026 HOLWAY ROAD, HOLYWELL:** from a point 640 metres North West of its junction with Saith Aelwyd Park, to a point 52 metres north west of its junction with Carmel Road.

1. In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
2. The Flintshire County Council (VARIOUS ROADS WITHIN FLINTSHIRE) (30 mph Speed Limit) Order 2023 shall have effect as though in the fifth Schedule to that Order, the words :-

**A5026 HOLWAY ROAD, HOLYWELL:** from a point 680 metres North West of its junction with Saith Aelwyd Park, to a point 52 metres north west of its junction with Carmel Road.

are deleted and replaced with:

**A5026 HOLWAY ROAD, HOLYWELL:** from a point 640 metres North West of its junction with Saith Aelwyd Park, to a point 52 metres north west of its junction with Carmel Road.

3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

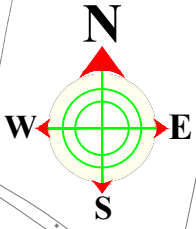

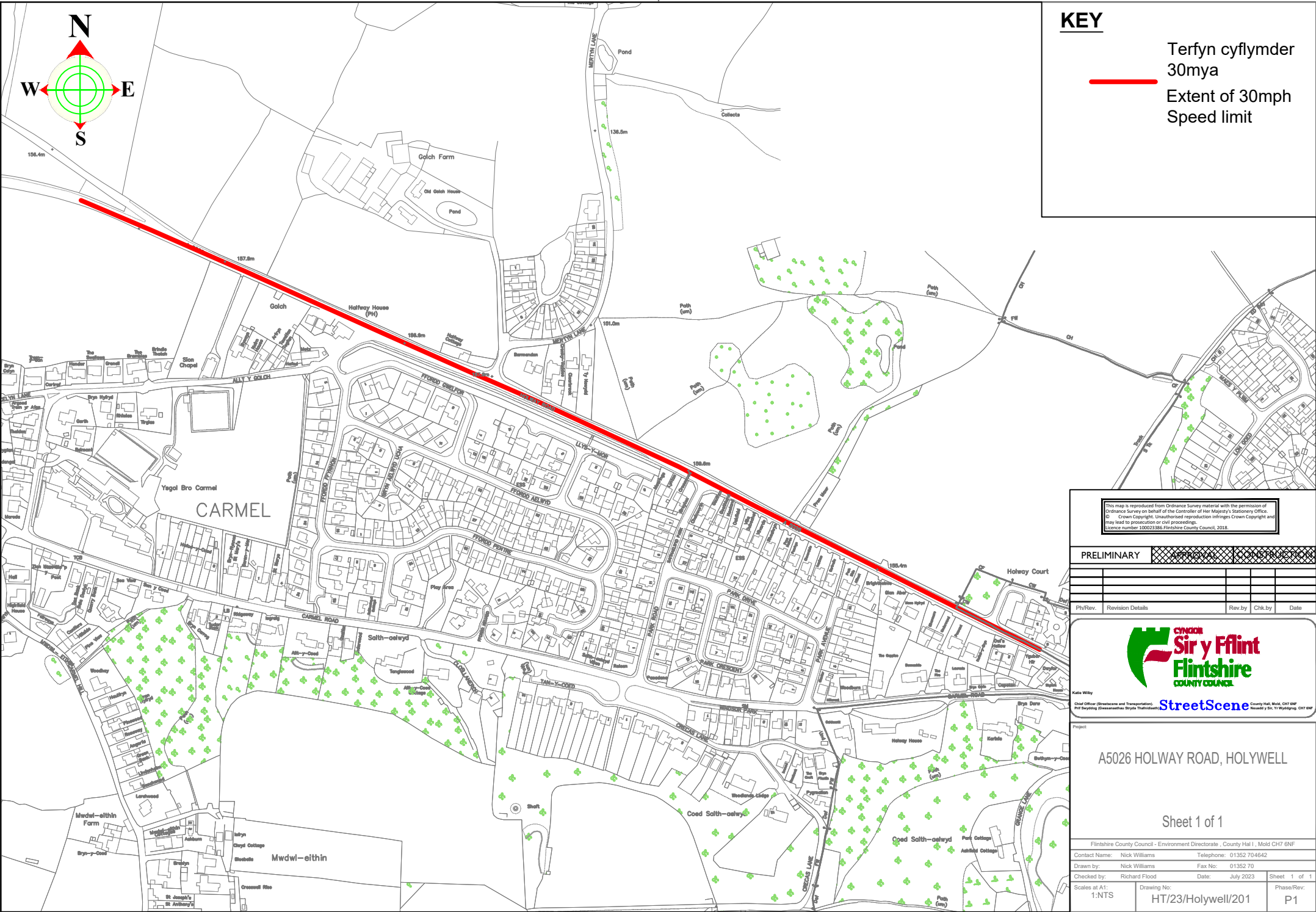
