Flintshire County Council in exercise of its powers under sections 1 (1), 2 (1)(2), 4 (2)(3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") as amended, the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

SECTION 1 – PRELIMINARY

Citation and commencement

1. This Order shall come into operation on the 28th March 2025 and may be cited as The Flintshire County Council, GOLFTYN LANE, KELSTERTON COURT, VERMEER CLOSE, GOLFTYN DRIVE, HAFOD CLOSE, HOLLY CLOSE, HALS CLOSE AND COLLEGE VIEW, CONNAH'S QUAY (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) (Amendment No. 66) Order 2025.
2. With effect from the date set out in Article 1 above, Map Schedule AT69 Sheet Revision No: 2 replaces Map Schedule AT69 Sheet Revision 1 and Map Schedule AT70, Sheet Revision No: 3, replaces Map Schedules AT70 Sheet Revision No: 2 and all other map schedules together with the before mentioned map schedules and plans referred to in the Schedules to this Order are incorporated into The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013.
3. The interpretation Act 1978 shall apply for the interpretation on this Order as it applies for the interpretation of an Act of Parliament.

4. In this Order, except where otherwise stated, any reference to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number and any reference to a plan is reference to a plan incorporated into this Order.
